# MARKET SUMMARIES FOR FEBRUARY

### Pacific Northwest (FO 124)


Producers delivered a total of 604.4 million pounds of milk to the market during February. Daily deliveries averaged 21.6 million pounds, down 13.1 percent from January. An estimated 396 producers delivered milk to the market during the month. Daily deliveries per producer averaged 54,506 pounds, up 12.8 percent from January.

Class I producer milk during February totaled 138.9 million pounds, 23.0 percent of total producer receipts. Daily usage averaged 5.0 million pounds, down 2.2 percent from January.

#### Arizona (FO 131)

Producers delivered a total of 413.7 million pounds of milk to the market during February. Daily deliveries averaged 14.8 million pounds, up 2.7 percent from January. An estimated 80 producers delivered milk to the market during the month. Daily deliveries per producer averaged 184,700 pounds, up 2.7 percent from January.

Class I producer milk during February totaled 97.6 million pounds, 23.6 percent of total producer receipts. Daily usage averaged 3.5 million pounds, down 1.5 percent from January.

#### **CURRENT COMMODITY PRICES**

The AMS survey of cheddar cheese prices showed an increase in prices received for 40-pound blocks and for 500-pound barrels. The survey of 40-pound blocks showed an increase of 15.47 cents between the February 16 and the March 16 surveys, to \$1.6211 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed an increase of 14.98 cents to \$1.4467 per pound.

The AMS butter price showed a net decrease of 0.54 cents between the weeks ending February 16 and March 16 from \$2.2966 per pound to \$2.2912 per pound. The AMS nonfat dry milk showed a net decrease of 2.57 cents since mid-February to \$0.9554 per pound. The average price for AMS whey showed a net decrease of 4.05 cents since mid-February to \$0.4150 per pound.

## USDA ANNOUNCES AMENDMENT TO CLASS I SKIM MILK PRICE FORMULA

On March 8, 2019, the U.S. Department of Agriculture (USDA) announced an amendment to the Class I skim milk price formula under the Federal Milk Marketing Order (FMMO) program, in accordance with the Agriculture Improvement Act of 2018 (2018 Farm Bill). The change is effective May 1, 2019. The new price formula will be reflected in the May Advanced Class I Skim Milk Price that will be announced on April 17, 2019.

Currently, the Class I skim milk price is calculated using the higher of the monthly advanced pricing factors for Class III or Class IV skim milk, which reflect dairy product survey prices for the two weeks prior to the price announcement, plus the applicable adjusted Class I differential. Because market prices for these surveyed products fluctuate, the "higher of" factor used to determine the Class I skim milk price can change, increasing risk and uncertainty associated with hedging.

To address this issue, Congress determined that the formula for the FMMO Class I skim milk price should be the average of the monthly Class III and Class IV advanced pricing factors plus \$0.74 per hundredweight plus the applicable adjusted Class I differential. In accordance with the 2018 Farm Bill, the amendment is effective indefinitely, until further modified, and may not be modified sooner than two years after the effective date of this rule.

### USDA SEEKS NOMINEES FOR NATIONAL DAIRY PROMOTION AND RESEARCH BOARD

The U.S. Department of Agriculture (USDA) is asking dairy producers and other interested parties to nominate candidates to serve on the National Dairy Promotion and Research Board. The deadline for nominations is April 15, 2019.

Agriculture Secretary Sonny Perdue will appoint 12 individuals to succeed members whose terms expire on October 31, 2019.

USDA will accept nominations for board representation in eight geographic regions. Nominees for the regional positions must be dairy producers.

The geographic regions with vacancies are: Region 2 (Calif. and Hawaii); Region 3 (Ariz., Colo., Mont., Nev., Utah and Wyo.); Region 4 (Ark., Kan., N.M., Okla., and Texas); Region 6 (Wis.); Region 9 (Ind., Mich., Ohio, and W.Va.); Region 10 (Ala., District of Columbia, Fla., Ga., Ky., La., Miss., N.C., Puerto Rico, S.C., Tenn. and Va.); Region 11 (Del., Md., N.J., and Pa.); and Region 12 (Conn., Maine, Mass., N.H., N.Y., R.I., and Vt.).

Newly appointed members will serve three-year terms beginning on November 1, 2019, through October 31, 2022.

### **EXTENSION OF** DAIRY FORWARD PRICING PROGRAM

The Agricultural Improvement Act of 2018, signed into law on December 20, 2018, extended the authorization of the Dairy Forward Pricing Program contained in the Food, Conservation and Energy Act of 2008 (the 2008 Farm Bill), through September 30, 2023. Handlers may now enter new forward pricing contracts with producers or cooperative associations of producers through September 30, 2023. Contracts may extend through September 30, 2026. All other provisions of the Dairy Forward Pricing Program remain the same.

The final rule extending the program was posted on the Federal Register website for public display at: https://www.federalregister.gov/public-inspection/current.

### Please keep in mind:

- All new contracts must be signed by both parties prior to the effective month. The signed contract and disclosure statement must be received by the Market Administrator prior to the 15th of the applicable month. For example, to contract for April 2019 milk, the forward contract and disclosure statement must be signed prior to April 1, 2019, and received by the Market Administrator by April 15, 2019.
- The disclosure statement must be signed on the same date as the contract.
- Producer milk that has been forward contracted under the terms of the program is not subject to minimum payment to a producer or cooperative association under a Federal Order.
- For contracts signed between September 30, 2018, and March 3, 2019, if the Market Administrator has already received a copy of the contract and disclosure statement or receives them by March 15, 2019, and the contract includes March milk deliveries, the contract applies only to milk marketed on or after March 4, 2019. This holds true even if contract deliveries began in a prior month. However, contracts cannot be included in the program if the disclosure statement has a date other than the date on which the contract was signed. In this case, if a handler and producer would like to have a valid contract applicable under the program, another contract must be negotiated.
- For contracts signed between September 30, 2018, and March 3, 2019, there will be no allowance for payments less than the Federal order minimum for milk marketed between October 2018 and March 3, 2019.

Forward Contracts established under this program may not extend past September 30, 2026. Forward contracts established prior to October 1, 2018, are not impacted.
