MARKET SUMMARIES FOR FEBRUARY

Pacific Northwest (FO 124)


Producers delivered a total of 440.3 million pounds of milk to the market during February. Daily deliveries averaged 15.7 million pounds, down 33.0 percent from January. An estimated 444 producers delivered milk to the market during the month. Daily deliveries per producer averaged 35,420 pounds, down 11.7 percent from January.

Class I producer milk during February totaled 160.8 million pounds, 36.5 percent of total producer receipts. Daily usage averaged 5.7 million pounds, down 2.5 percent from January.

Arizona (FO 131)

Producers delivered a total of 390.5 million pounds of milk to the market during February. Daily deliveries averaged 13.9 million pounds, up 3.9 percent from January. An estimated 92 producers delivered milk to the market during the month. Daily deliveries per producer averaged 151,579 pounds, up 3.9 percent from January.

Class I producer milk during February totaled 101.1 million pounds, 25.9 percent of total producer receipts. Daily usage averaged 3.6 million pounds, down 7.1 percent from January.

CURRENT COMMODITY PRICES

The AMS survey of cheddar cheese prices showed a net decrease in prices received for 40-pound blocks and for 500-pound barrels. The survey of 40-pound blocks showed a net decrease of 11.74 cents between the February 15 and the March 15 surveys, to \$2.2044 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed a net decrease of 9.00 cents to \$2.2344 per pound.

The AMS butter price showed a net decrease of 1.89 cents between the weeks ending February 15 and March 15 from \$1.8585 per pound to \$1.8396 per pound. The AMS nonfat dry milk showed a net increase of 2.13 cents since mid-February to \$2.0984 per pound. The average price for AMS whey showed an increase of 2.23 cents since mid-February to \$0.6506 per pound.

USDA SEEKS NOMINATIONS FOR THE NATIONAL ORGANIC STANDARDS BOARD

The U.S. Department of Agriculture (USDA) is seeking nominations to fill four vacancies on the National Organic Standards Board (NOSB).

Vacancies for the 15-member organic standards board need to be filled for an environmentalist, organic producer, organic handler, and retailer. The positions are specifically designated to represent various sectors of the organic community, including those who have expertise in areas of environmental protection and resource conservation, own or operate an organic production or handling operation, or own or operate a retail establishment with significant trade in organic products.

The NOSB is responsible for reviewing materials and/or recommending changes to the National List of Allowed and Prohibited Substances and advising the Secretary of Agriculture on other aspects of the USDA organic regulations.

Appointees will serve a 5-year term of office beginning January 24, 2015.

Written nominations, with cover letters, resumes and a required form, must be postmarked on or before May 15, 2014. Nominations can also include endorsements or letters of recommendations. USDA ISSUES A FINAL RULE EXTENDING THE DAIRY FORWARD PRICING PROGRAM

On March 20, 2014, the U.S. Department of Agriculture (USDA) issued a final rule extending the Dairy Forward Pricing Program to allow producers and cooperative associations to enter into forward price contracts through September 30, 2018. This final rule also extends all other requirements of the program until September 30, 2021.

The Dairy Forward Pricing Program allows producers and producer cooperative associations to voluntarily enter into forward price contracts with handlers for milk under the Agricultural Marketing Agreement Act of 1937.

The program has not accepted new contracts since September 30, 2013. The 2014 Farm Bill allows new contracts to be entered into until September 30, 2018. Contracts may not extend beyond September 30, 2021.

2013 YEAR END FINANCIAL STATEMENTS

The financial statements for the Administrative and Marketing Services



Funds of the Pacific Northwest and Arizona Federal Milk Marketing Orders for the calendar year ending December 31, 2013, can be found on page 5. The two orders require that the market administrator conduct a marketing service program for producers who are not members of a qualified cooperative association which performs comparable services.

The primary functions of the marketing service involve the sampling and testing of milk, and providing marketing information to producers. The principal source of income for these programs is the marketing service deduction which is applicable to all producers for whom the services are provided.

USDA ANNOUNCES FINAL DECISIONS TO AMEND THE APPALACHIAN, SOUTHEAST, AND FLORIDA MILK MARKETING ORDERS

On March 6, 2014, the U.S. Department of Agriculture (USDA) announced two final decisions that permanently adopt amendments to the Appalachian, Southeast, and Florida federal milk marketing orders.

The first final decision is based on testimony and evidence given at a public hearing held in Louisville, Kentucky, from January 10-12, 2006. Specifically, this decision: Establishes a mileage rate factor using a fuel cost adjustor used in the transportation credit provisions of the Appalachian and Southeast orders, increases the maximum transportation credit assessment rate for both orders, and establishes a zero diversion limit standard on loads of milk requesting transportation credits. These amendments have been in place on an interim basis since 2006.

The second final decision is based on testimony and evidence given at a public hearing held in Tampa, Florida, from May 21-23, 2007. In addition to adjusting the Class I pricing surface for the Appalachian, Florida, and Southeast orders, this decision amends certain features of the diversion limit, touch-base and transportation credit provisions for the Appalachian and Southeast orders. These amendments have been in place on an interim basis since 2008. This decision also increases the maximum administrative assessment for the Appalachian, Florida, and Southeast marketing orders.

USDA will conduct a vote on the amended orders to determine producer approval. If producers approve the orders as amended, final rules will follow to implement these changes on a permanent basis. The final decisions were published in the March 7, 2014, *Federal Register*. For more information contact the market administrator offices for the Appalachian, Southeast, and Florida orders. **T**
