### MARKET SUMMARIES FOR JUNE 2005

Comparisons to a year ago can be found in the tables on pages 6 and 7.

#### Pacific Northwest

Producers delivered a total of 609.0 million pounds of milk to the market during June. Daily deliveries averaged 20.3 million pounds, up 0.01 percent from May. An estimated 854 producers delivered milk to the market during the month. Daily deliveries per producer averaged 23,770 pounds, up 0.01 percent from May.

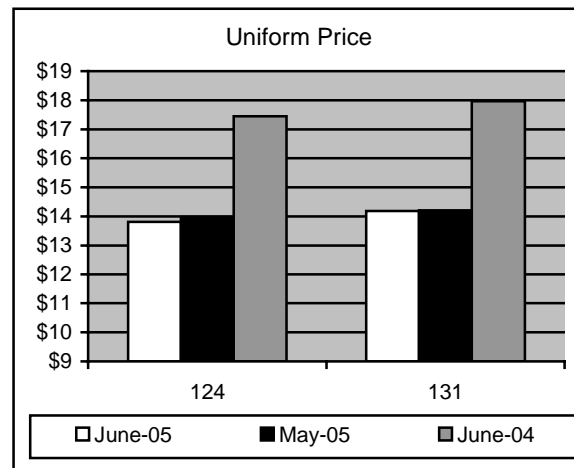
Class I producer milk during June totaled 164.9 million pounds, 27.1 percent of total producer receipts. Daily usage averaged 5.5 million pounds, down 5.5 percent from May.

#### Arizona-Las Vegas

Producers delivered a total of 249.6 million pounds of milk to the market during June. Daily deliveries averaged 8.3 million pounds, down 3.3 percent from May. An estimated 88 producers delivered milk

to the market during the month. Daily deliveries per producer averaged 94,534 pounds, down 3.3 percent from May.

Class I producer milk during June totaled 76.0 million pounds, 30.5 percent of total producer receipts. Daily usage averaged 2.5 million pounds, up 3.31 percent from May. ♦

**JUNE 2005 CLASS PRICES**

June 2005 non-advanced Class Prices were calculated using NASS commodity price surveys from June 4, 11, 18, and 25, 2005. Component prices for the month are \$2.5741 per pound of protein, \$1.5932 per pound of butterfat, \$0.1139 per pound of other solids, and \$0.7780 per pound of nonfat solids.

June 2005 Class III and IV prices at 3.5% butterfat are \$13.92 and \$12.33 per hundredweight, respectively. The June Class III price compared to May is up \$0.15. The Class III price is \$3.76 lower than June 2004. The Class III price at 3.67% butterfat is \$4.28 above the support price of \$9.90 at 3.67% butterfat.

Class II butterfat was announced at \$1.6002 per pound. Class I skim and butterfat and Class II skim prices for June 2005 were announced on May 20, 2005. The Class II price at 3.5% butterfat is \$13.06 for June 2005.

**Current Commodity Prices** - - The NASS survey of cheddar cheese prices showed an increase in prices received for 40-pound blocks and a net increase for 500-pound barrels. The survey of 40-pound blocks showed an increase of 4.42 cents between the June 18 and the July 16 surveys, to \$1.5241 per pound. The survey of 500-pound barrels (**adjusted to 38% moisture**) showed a net increase of 4.22 cents to \$1.5068 per pound.

The NASS butter price showed a net increase of 19.75 cents between the weeks ending June 18 and July 16 from \$1.4339 per pound to \$1.6314 per pound.

The NASS nonfat dry milk showed an increase of 1.67 cents since mid-June to \$0.9383 per pound. The average price for NASS whey showed a net increase of 0.86 cent since mid-June to \$0.2804 per pound. ♦

**AUGUST'S CLASS I PRICE ANNOUNCEMENT**

On July 22, the August 2005 Class I price was announced at \$16.34 for the Pacific Northwest Order, and \$16.79 for the Arizona-Las Vegas Order. The Class I price was calculated using NASS commodity price surveys from the weeks of July 9 and 16.

The August Class III and IV advance skim prices are \$8.29 and \$7.11 per hundredweight, respectively. The butterfat portion of the Class I mover increased 27.86 cents from \$1.5610 to \$1.8396 per pound.

The August 2005 Class II skim and nonfat solids prices were also announced on July 22. The skim price is \$7.81 per hundredweight, and the nonfat solids price is \$0.8678 per pound for all Federal orders. ♦

**USDA ANNOUNCES PARTIAL FINAL DECISION TO AMEND THE ARIZONA - LAS VEGAS MILK MARKETING ORDER**

On June 24, 2005, the U. S. Department of Agriculture announced a partial final decision that permanently adopts an amendment to the pooling provisions of the Arizona-Las Vegas milk marketing order that previously were implemented on an interim basis. This decision is based on testimony and evidence given at a public hearing held at Tempe, Arizona, on September 23-25, 2003; reconvened at Seattle, Washington, on November 17-21, 2003; and reconvened at Alexandria, Virginia, on January 20-22, 2004.

This partial final decision permanently adopts an amendment to the Producer milk provision that would eliminate the ability to simultaneously pool milk on the Arizona-Las Vegas milk order when the same milk is already pooled on a State-operated milk order that has marketwide pooling.

The partial final decision was published in the June 27, 2005, Federal Register. USDA is

conducting a vote on the amended order to determine producer approval. If producers approve the order as amended by this final decision, a final rule will follow to implement these changes on a permanent basis.

**PRODUCERS AND PRODUCER MILK BY ORDER, STATE, AND COUNTY, MAY 2005**

During the month of May 2005, a total of 942 producers, on a combined basis, were associated with the Pacific Northwest and Arizona-Las Vegas Orders. These producers delivered a total of 895.9 million pounds of milk to the markets during the month. The tables below and on page 4 contain information on the number of producers and milk pooled on the orders. Counties and states with fewer than three producers were combined with adjacent counties. The map on page 5 does not combine counties with fewer than three producers due to the use of size-ranges. ♦

**FIRST HALF U.S. MILK PRODUCTION UP 3.2 PERCENT**

Milk production for the first six months of 2005 was up 3.2 percent for the U.S. and up 3.5 percent for the top 23 states compared with 2004, on a daily basis. The table to the right shows data for

2005 for the selected states with comparisons to year-ago levels.

Milk production for June 2005 was up 5.0 percent for the United States compared with June 2004. United States milk production for June 2005 equaled 15,012 million pounds, 719 million pounds more than last June. For the top 23 states, milk production was up 5.4 percent from June 2004. The table below shows comparisons to year-ago levels. ♦

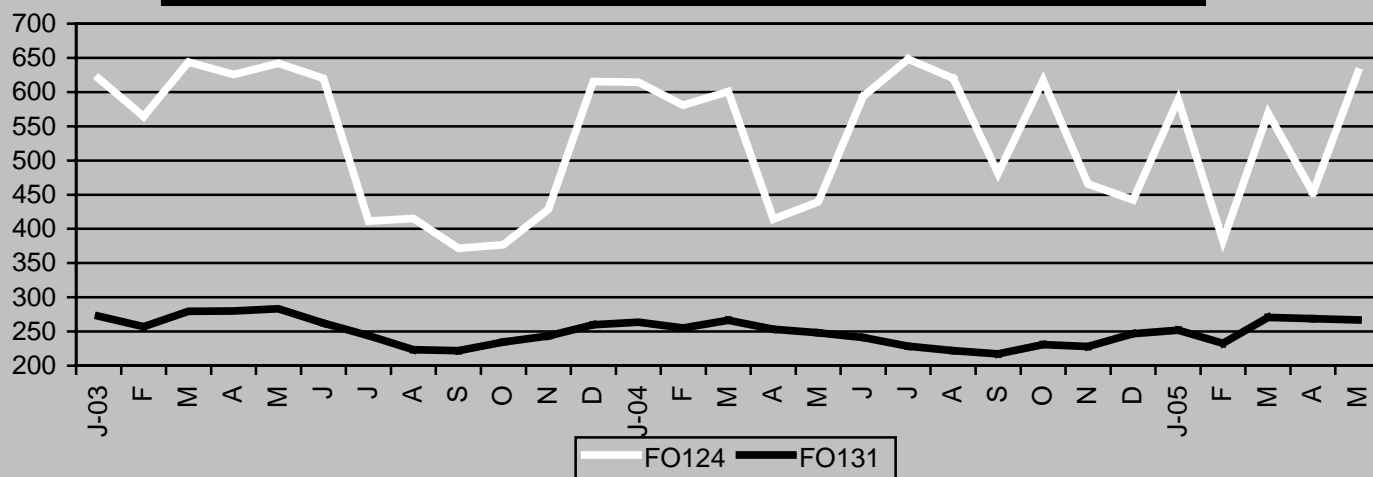

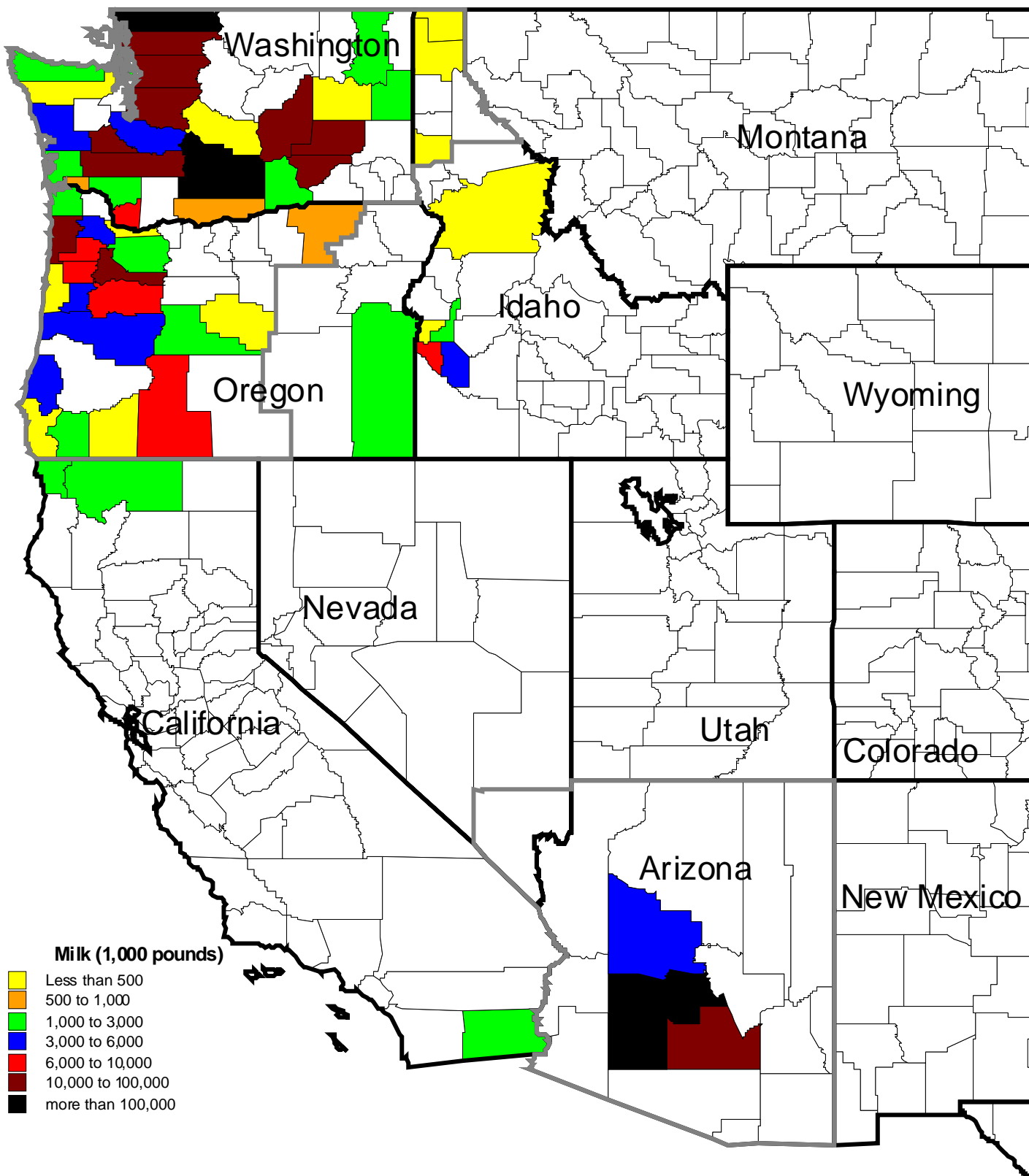
