### MARKET SUMMARIES FOR OCTOBER

#### Pacific Northwest (FO 124)


Producers delivered a total of 624.4 million pounds of milk to the market during October. Daily deliveries averaged 20.1 million pounds, up 0.3 percent from September. An estimated 482 producers delivered milk to the market during the month. Daily deliveries per producer averaged 41,791 pounds, up 0.3 percent from September.

Class I producer milk during October totaled 186.6 million pounds, 29.9 percent of total producer receipts. Daily usage averaged 6.0 million pounds, up 3.7 percent from September. **T** 

#### Arizona (FO 131)

Producers delivered a total of 367.8 million pounds of milk to the market during October. Daily deliveries averaged 11.9 million pounds, up 7.3 percent from September. An estimated 93 producers delivered milk to the market during the month. Daily deliveries per producer averaged 127,573 pounds, up 7.3 percent from September.

Class I producer milk during October totaled 117.4 million pounds, 31.9 percent of total producer receipts. Daily usage averaged 3.8 million pounds, up 2.4 percent from September.

#### **CURRENT COMMODITY PRICES**

The AMS survey of cheddar cheese prices showed an increase in prices received for 40-pound blocks and for 500-pound barrels. The survey of 40-pound blocks showed an increase of 8.79 cents between the October 19 and the November 16 surveys, to \$1.8768 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed an increase of 9.56 cents to \$1.8648 per pound.

The AMS butter price showed a net decrease of 6.58 cents between the weeks ending October 19 and November 16 from \$1.5677 per pound to \$1.5019 per pound. The AMS nonfat dry milk showed an increase of 4.82 cents since mid-October to \$1.8914 per pound. The average price for AMS whey showed a net increase of 0.61 cents since mid-October to \$0.5774 per pound.

## Market Administrator News

#### WAIVER OF ADMINISTRATIVE ASSESSMENT

On October 28, 2013, the market administrator issued a handler letter announcing that the 3.5cent per hundredweight administrative assessment currently applicable to the Pacific Northwest and Arizona federal milk orders will be waived for the months of October, November, and December 2013. Statements issued for those months will not contain an administrative assessment charge.

The 4-cent per hundredweight deduction for marketing services under each of the above-named orders will continue to be deducted. This deduction, which is applicable to deliveries by producers who are not members of a qualified cooperative association performing marketing services, is to be withheld from producers in making payments for milk delivered during the month.

#### USDA ANNOUNCES NATIONAL DAIRY BOARD APPOINTMENTS

Agriculture Secretary Tom Vilsack announced the appointment of 14 members to the National Dairy Promotion and Research Board on November 1, 2013. Thirteen appointees will serve three-year terms and one will serve a two-year term.

"These appointees represent a cross section of the dairy industry and I am confident that the industry will be well served by them" said Secretary Vilsack.

Newly appointed members are: Carol L. Ahlem, Hilmar, California (Region 2); Christopher J. Brazil, Escalon, California (Region 2); Brian O. Medeiros, Hanford, California (Region 2); Lisa Vander Eyk, Pixley, California (Region 2); Eddie S. Schaap, Clovis, New Mexico (Region 4); Sarah E. Lloyd, Wisconsin Dells, Wisconsin (Region 6); Cheryl L. Chapin, Remus, Michigan (Region 9); and Joseph M. Kelsay (term ending on October 31, 2015), Whiteland, Indiana (Region 9).

Reappointed to serve second terms were: Renae A. De Jager, Chowchilla, California (Region 2); Jeffrey A. Hardy, Brigham City, Utah (Region 3); Zachary H. Myers, Jonesville, North Carolina (Region 10); David P. Crowl, Forest Hill, Maryland (Region 11); Sanford Stauffer, Nicholville, New York (Region 12); and Susan M. Troy, Wilmette, Illinois (Importer).

The Dairy Board was established under the Dairy Production Stabilization Act of 1983, as amended, to develop and administer a coordinated program of promotion, research, and nutrition education. The 38-member Dairy Board is authorized to design programs to strengthen the dairy industry's position in domestic and foreign markets. The Secretary selected the appointees from nominations submitted by eligible producer organizations, general farm organizations, and qualified dairy products promotion, research or nutrition education programs. USDA's Agricultural Marketing Service monitors the operation of the Dairy Board.

#### USDA SEEKS NOMINEES FOR NATIONAL FLUID MILK PROCESSOR PROMOTION BOARD

The U.S. Department of Agriculture (USDA) is asking fluid milk processors and other interested parties to nominate candidates for the National Fluid Milk Processor Promotion Board.

The Secretary of Agriculture will appoint seven individuals from those nominated to succeed members whose terms expire June 30, 2014. Appointed members will serve three-year terms from July 1, 2014, through June 30, 2017.

USDA will accept nominations for board representation in six geographic regions and one at-large position. Nominees for the six regional positions must be active owners or employees of a fluid milk processor. The atlarge position may be filled by either a processor or public member. The geographic regions are: Region 2 (New Jersey and New York); Region 5 (Florida); Region 8 (Illinois and Indiana); Region 11 (Arkansas, Iowa, Kansas, Missouri, Nebraska, and Oklahoma); Region 13 (Idaho, Montana, Oregon, Washington, and Wyoming); and Region 14 (Northern California).

#### NASS TO RELEASE PRELIMINARY RESULTS OF 2012 CENSUS OF AGRICULTURE ON FEBRUARY 20, 2014

USDA's National Agricultural Statistics Service (NASS) will release preliminary results of the 2012 Census of Agriculture on February 20, 2014. The release, which will provide an initial look at national and state findings, will take place at the Agricultural Outlook Forum. NASS will release the full Census results at a later date and is working to set a revised schedule that ensures the highestguality data. The release date was delayed by the work stoppage caused by the lapse in federal funding in October 2013.

#### RECORD SALES, INCOME AND ASSETS FOR AGRICULTURE AND FISHERY COOPERATIVES

In recognition of October as National Cooperative Month, on October 23, 2013, Agriculture Secretary Tom Vilsack announced that U.S. farmer, rancher and fishery cooperatives set records for sales, income and assets in 2012, buoyed by strong prices for grain, farm supplies and many other agricultural commodities. Sales by agricultural and fishery co-ops of nearly \$235 billion surpassed the 2011 record by \$18 billion, an 8.3 percent gain. Record net (pretax) income of \$6.1 billion was up nearly 13 percent over the \$5.4 billion recorded in 2011. **T** 

#### STATEMENT FROM AGRICULTURE SECRETARY TOM VILSACK ON U.S. AGRICULTURAL EXPORTS IN 2013

On November 14, 2013, USDA released its final tally for agricultural exports in Fiscal Year 2013, showing a new record of \$140.9 billion. Agriculture Secretary Tom Vilsack made the following statement on this news:

"American agriculture achieved record exports once again in Fiscal Year 2013, and the period 2009-2013 stands as the strongest five-year period for agricultural exports in our nation's history. In fact, compared to the previous five-year period from 2004-2008, U.S. agricultural exports from 2009-2013 increased by a total of more than \$230 billion - and the average volume of bulk commodities exported increased by nearly four million tons per year during that same period. We need to remain focused on keeping up the incredible momentum we've seen over the past five years. First and foremost, Congress needs to pass a new Food, Farm and Jobs Bill to continue the trade promotion programs that helped American agriculture achieve these results. These trade promotion efforts return \$35 in economic benefits for every dollar invested - a great value for producers who gain access to additional market opportunities abroad, as well as rural communities that depend on a solid agriculture sector to create and support jobs. A new Farm Bill would complement historic work by the Obama Administration to break down barriers to U.S. products and achieve new agreements to expand exports - an effort that continues today as we work toward new agreements with the European Union and a number of Asian nations. With record agricultural exports supporting about one million American jobs, we can't afford to lose the incredible momentum of recent years - and that's why we need Congress to pass a new Food, Farm and Jobs Bill as soon as possible." **T** 

#### MILK PRODUCTION

On November 19, 2013, USDA's National Agricultural Statistics Service announced that milk production in the 23 major States during October totaled 15.4 billion pounds, up 1.2 percent from October 2012. September revised production, at 14.8 billion pounds, was up 1.0 percent from September 2012. Production per cow in the 23 major States averaged 1,806 pounds for October, 14 pounds above October 2012. The number of milk cows on farms in the 23 major States was 8.50 million head, 36,000 head more than October 2012, but 2,000 head less than September 2013. **T**
