MARKET SUMMARIES FOR NOVEMBER

Pacific Northwest (FO 124)

Producers delivered a total of 586.0 million pounds of milk to the market during November. Daily deliveries averaged 19.5 million pounds, down 1.7 percent from October. An estimated 354 producers delivered milk to the market during the month. Daily deliveries per producer averaged 55,175 pounds, down 1.7 percent from October.

Class I producer milk during November totaled 140.9 million pounds, 24.0 percent of total producer receipts. Daily usage averaged 4.7 million pounds, up 0.9 percent from October. 📉

Arizona (FO 131)

Producers delivered a total of 316.0 million pounds of milk to the market during November. Daily deliveries averaged 10.5 million pounds, up 8.1 percent from October. An estimated 67 producers delivered milk to the market during the month. Daily deliveries per producer averaged 157,210 pounds, up 8.1 percent from October.

Class I producer milk during November totaled 108.0 million pounds, 34.2 percent of total producer receipts. Daily usage averaged 3.6 million pounds, up 2.9 percent from October. 📈

CURRENT COMMODITY PRICES

The AMS survey of cheddar cheese prices showed a decrease in prices received for 40-pound blocks and a decrease for 500-pound barrels. The survey of 40-pound blocks showed a decrease of 104.13 cents between the November 14 and the December 19 surveys, to \$1.6959 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed a decrease of 103.42 cents to \$1.4566 per pound.

The AMS butter price showed a net increase of 0.67 cents between the weeks ending November 14 and December 19 from \$1.4710 per pound to \$1.4777 per pound. The AMS nonfat dry milk showed a net increase of 2.11 cents since mid-November to \$1.1047 per pound. The average price for AMS whey showed a net increase of 4.61 cents since mid-November to \$0.4264 per pound. 🐄

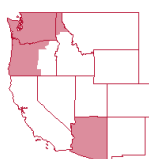
