MARKET SUMMARIES FOR JUNE

Pacific Northwest (FO 124)

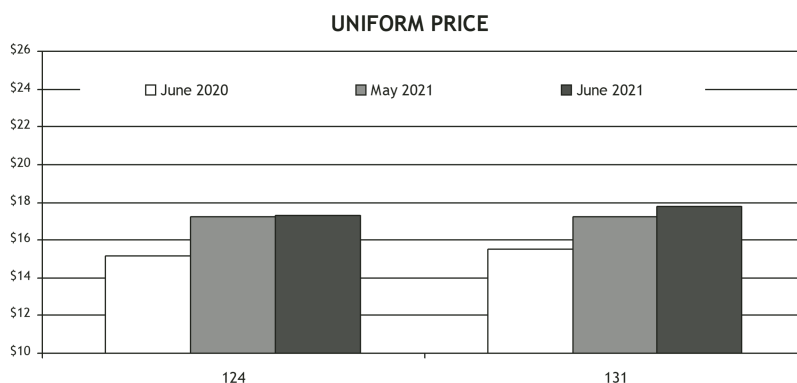
Producers delivered a total of 598.3 million pounds of milk to the market during June. Daily deliveries averaged 19.9 million pounds, down 2.2 percent from May. An estimated 343 producers delivered milk to the market during the month. Daily deliveries per producer averaged 58,144 pounds, down 2.2 percent from May.

Class I producer milk during June totaled 124.5 million pounds, 20.81 percent of total producer receipts. Daily usage averaged 4.2 million pounds, down 3.5 percent from May. 🐄

Arizona (FO 131)

Producers delivered a total of 390.1 million pounds of milk to the market during June. Daily deliveries averaged 13.0 million pounds, up 9.3 percent from May. An estimated 59 producers delivered milk to the market during the month. Daily deliveries per producer averaged 220,379 pounds, up 13.0 percent from May.

Class I producer milk during June totaled 109.2 million pounds, 28.0 percent of total producer receipts. Daily usage averaged 3.6 million pounds, up 4.5 percent from May. 🐄

CURRENT COMMODITY PRICES

The AMS survey of cheddar cheese prices showed a net increase in prices received for 40-pound blocks and a net decrease for 500-pound barrels. The survey of 40-pound blocks showed a net increase of 2.85 cents between the June 19 and the July 17 surveys, to \$1.5853 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed a net decrease of 7.30 cents to \$1.5635 per pound.

The AMS butter price showed a net decrease of 5.86 cents between the weeks ending June 19 and July 17 from \$1.7850 per pound to \$1.7264 per pound. The AMS nonfat dry milk showed a decrease of 2.43 cents since mid-June to \$1.2501 per pound. The average price for AMS whey showed a net decrease of 2.82 cents since mid-June to \$0.5968 per pound. 🐄
