MARKET SUMMARIES FOR NOVEMBER

Pacific Northwest (FO 124)


Producers delivered a total of 549.4 million pounds of milk to the market during November. Daily deliveries averaged 18.3 million pounds, down 1.8 percent from October. An estimated 334 producers delivered milk to the market during the month. Daily deliveries per producer averaged 54,831 pounds, down 1.8 percent from October.

Class I producer milk during November totaled 138.7 million pounds, 25.3 percent of total producer receipts. Daily usage averaged 4.6 million pounds, up 6.7 percent from October. **T**

Arizona (FO 131)

Producers delivered a total of 401.8 million pounds of milk to the market during November. Daily deliveries averaged 13.4 million pounds, up 13.0 percent from October. An estimated 63 producers delivered milk to the market during the month. Daily deliveries per producer averaged 212,596 pounds, up 13.0 percent from October.

Class I producer milk during November totaled 119.0 million pounds, 29.6 percent of total producer receipts. Daily usage averaged 4.0 million pounds, up 3.9 percent from October. **Y**

CURRENT COMMODITY PRICES

The AMS survey of cheddar cheese prices showed a net increase in prices received for 40-pound blocks and a net decrease for 500-pound barrels. The survey of 40-pound blocks showed a net increase of 11.96 cents between the November 13 and the December 18 surveys, to \$1.8767 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed a net decrease of 10.64 cents to \$1.6412 per pound.

The AMS butter price showed a net increase of 11.11 cents between the weeks ending November 13 and December 18 from \$1.9496 per pound to \$2.0607 per pound. The AMS nonfat dry milk showed a net increase of 6.55 cents since mid-November to \$1.5521 per pound. The average price for AMS whey showed an increase of 6.04 cents since mid-November to \$0.6324 per pound. **T**

USDA OPENS 2022 DAIRY MARGIN COVERAGE SIGNUP

The following is an excerpt of a statement released by the U.S. Department of Agriculture (USDA) on December 8.

As part of the Biden-Harris Administration's ongoing efforts to support dairy farmers and rural communities, the U.S. Department of Agriculture (USDA) opened signup for the Dairy Margin Coverage (DMC) program and expanded the program to allow dairy producers to better protect their operations by enrolling supplemental production. This signup period, which runs from December 13, 2021 to February 18, 2022, enables producers to get coverage through this important safety-net program for another year as well as get additional assistance through the new Supplemental DMC.

Supplemental DMC will provide \$580 million to better help small and mid-sized dairy operations that have increased production over the years but were not able to enroll the additional production. Now, they will be able to retroactively receive payments for that supplemental production. Additionally, USDA's Farm Service Agency (FSA) updated how feed costs are calculated, which will make the program more reflective of actual dairy producer expenses.

This announcement is part of a broader package to help the dairy industry respond to the pandemic and other challenges. USDA is also amending Dairy Indemnity Payment Program (DIPP) regulations to add provisions for the indemnification of cows that are likely to be not marketable for longer durations, as a result, for example, of per- and polyfluoroalkyl substances. FSA also worked closely with USDA's Natural Resources Conservation Service to target assistance through the Environmental Quality Incentives Program) and other conservation programs to help producers safely dispose of and address resource concerns created by affected cows. Other recent dairy announcements include \$350 million through the Pandemic Market Volatility Assistance Program and \$400 million for the Dairy Donation Program.

Additional details on these changes to DMC and DIPP can be found in a rule that will be published soon in the Federal Register. This rule also included information on the new Oriental Fruit Fly Program as well as changes to FSA conservation programs.
