### MARKET SUMMARIES FOR MARCH

#### Pacific Northwest (FO 124)

Producers delivered a total of 665.9 million pounds of milk to the market during March. Daily deliveries averaged 21.5 million pounds, down 10.3 percent from February. An estimated 319 producers delivered milk to the market during the month. Daily deliveries per producer averaged 67,337 pounds, up 14.7 percent from February.


Class I producer milk during March totaled 144.0 million pounds, 21.6 percent of total producer receipts. Daily usage averaged 4.6 million pounds, up 2.9 percent from February. ▼

#### Arizona (FO 131)

Producers delivered a total of 406.9 million pounds of milk to the market during March. Daily deliveries averaged 13.1 million pounds, down 10.6 percent from February. An estimated 62 producers delivered milk to the market during the month. Daily deliveries per producer averaged 211,709 pounds, down 10.6 percent from February.

Class I producer milk during March totaled 112.1 million pounds, 27.6 percent of total producer receipts. Daily usage averaged 3.6 million pounds, down 8.9 percent from February. ▼

## CURRENT COMMODITY PRICES

The AMS survey of cheddar cheese prices showed an increase in prices received for 40-pound blocks and an increase for 500-pound barrels. The survey of 40-pound blocks showed an increase of 16.25 cents between the March 19 and the April 16 surveys, to \$2.2744 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed an increase of 24.95 cents to \$2.2804 per pound.

The AMS butter price showed a net increase of 3.32 cents between the weeks ending March 19 and April 16 from \$2.7516 per pound to \$2.7848 per pound. The AMS nonfat dry milk showed a net increase of 3.51 cents since mid-March to \$1.8294 per pound. The average price for AMS whey showed a net decrease of 6.02 cents since mid-March to \$0.7293 per pound. ▼
