## MARKET SUMMARIES FOR MAY

#### Pacific Northwest (FO 124)

Producers delivered a total of 736.3 million pounds of milk to the market during May. Daily deliveries averaged 23.8 million pounds, up 23.3 percent from April. An estimated 364 producers delivered milk to the market during the month. Daily deliveries per producer averaged 65,254 pounds, down 0.7 percent from April.

Class I producer milk during May totaled 136.8 million pounds, 18.6 percent of total producer receipts. Daily usage averaged 4.4 million pounds, up 9.8 percent from April.

#### Arizona (FO 131)


Producers delivered a total of 428.1 million pounds of milk to the market during May. Daily deliveries averaged 13.8 million pounds, down 9.0 percent from April. An estimated 65 producers delivered milk to the market during the month. Daily deliveries per producer averaged 212,452 pounds, down 9.0 percent from April.

Class I producer milk during May totaled 110.4 million pounds, 25.8 percent of total producer receipts. Daily usage averaged 3.6 million pounds, down 0.5 percent from April.

#### **CURRENT COMMODITY PRICES**

The AMS survey of cheddar cheese prices showed a decrease in prices received for 40-pound blocks and a net decrease for 500-pound barrels. The survey of 40-pound blocks showed a decrease of 22.32 cents between the May 13 and the June 17 surveys, to \$1.5291 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed a net decrease of 1.00 cent to \$1.5792 per pound.

The AMS butter price showed a net decrease of 3.13 cents between the weeks ending May 13 and June 17 from \$2.4653 per pound to \$2.4340 per pound. The AMS nonfat dry milk showed a net increase of 2.48 cents since mid-May to \$1.1728 per pound. The average price for AMS whey showed a decrease of 7.23 cents since mid-May to \$0.3184 per pound.

#### **USDA ANNOUNCES \$23 MILLION AVAILABLE TO SUPPORT DAIRY INITIATIVES**

On June 8, 2023, the U.S. Department of Agriculture (USDA) announced \$23 million in grant funding is available to support processing capacity expansion, on-farm improvements, and technical assistance services to producers through the Dairy Business Innovation Initiatives.

The Dairy Business Innovation Initiatives provide valuable technical assistance and subgrants to dairy farmers and businesses across their regions, supporting them with business plan development, marketing, and branding, as well as increasing access to innovative production and processing techniques to support the development of value-added products.

"The Dairy Business Innovative Initiatives use their on-the-ground knowledge and their ability to target funding where it will have the most regional and local impacts to make significant improvements to the U.S. dairy supply chain," said USDA Under Secretary for Marketing and Regulatory Programs Jenny Lester Moffitt. "This program is a great example of USDA's efforts to build capacity from the bottom up and the middle out by supporting small and mid-sized dairy operations."

The funds will be awarded noncompetitively to the current initiatives at the California State University Fresno; the University of Tennessee; Vermont Agency of Agriculture, Food & Markets; and the University of Wisconsin. Through the Request for Applications (RFA), the initiatives will have an opportunity to submit proposals for this year's funding. Dairy farmers and businesses interested in the program must contact the appropriate initiative to be considered for direct technical assistance or a subaward.

AMS encourages applications to identify activities that benefit smaller farms and ranches, new and beginning farmers and ranchers, underserved producers, veteran producers, low-income, and minority individuals, and underserved communities. AMS also encourages partnerships with minority-serving institutions of higher education. For projects intending to serve these entities, applicants should engage and involve those beneficiaries when developing projects and applications.

The Request for Applications (RFA), information about grant eligibility, and a list of previously funded projects are available on the Dairy Business Innovation Initiative webpage. Applications must be submitted electronically through grants.gov by 11:59 p.m. Eastern Time on August 10, 2023.

### **Market Aadministrator News**

#### CONTINUATION OF REVISION IN SHIPPING PERCENTAGES

The following is an excerpt of a letter sent to FO 124 pool handlers.

**SUMMARY:** This action continues the reduction of the percentage of a cooperative association's producer milk that must be delivered to pool distributing plants to qualify its manufacturing plant for pool status. The order states that a specified percentage of producer milk must be delivered to pool distributing plants during either the current month or, on average, the immediately preceding 12-month period ending with the current month to qualify a cooperative's plant.

The purpose of this standard is to assure an adequate supply of milk for fluid consumption while enabling the continued pooling of producer milk that currently is pooled without the need for uneconomic movements of milk, which would result in disorderly marketing. To accomplish this goal, the order must reflect the needs and nature of the market.

The minimum shipping percentages applicable pursuant to this revision are: 15%, effective July 1, 2023.

**STATEMENT OF CONSIDERATION:** This proposed action is a continuation of the request made in May 2019 and granted in June 2019, effective from July 1, 2019, through June 30, 2020. At that time, Dairy Farmers of America (DFA) requested the Market Administrator review the request annually. As a result, each subsequent year a request for comments was issued and a continued revision was granted through June 30, 2021, 2022, and 2023.

On May 17, 2023, this office notified Federal Order 124 handlers of a Proposed Continuation of Revision in Shipping Percentages for Manufacturing Plants Operated by a Cooperative Association and invited the submission of comments, data, or views on this request by no later than June 23, 2023.

One written comment was received. Northwest Dairy Association (NDA) submitted a comment in favor of continuing the reduced shipping percentages. NDA recommends a review of market conditions in 2024. In addition, an analysis of the current and projected Federal Order 124 marketing conditions was performed by this office

Based on the comment received and analysis of available information and data, it is determined that until such time as marketing conditions warrant further review, the percentage of producer milk that a cooperative association must deliver to pool distributing plants during the current month or, on average, the immediately preceding 12-month period ending with the current month, are revised to the following schedule: January - December 15 percent.

As provided in section 1124.7(g) of the Pacific Northwest Federal Milk Marketing Order, the Market Administrator may review the need for any further adjustment on the Market Administrator's own initiative or at the request of interested parties.
