MARKET SUMMARIES FOR JANUARY

Pacific Northwest (FO 124)

Producers delivered a total of 608.7 million pounds of milk to the market during January. Daily deliveries averaged 19.6 million pounds, up 0.3 percent from December. An estimated 261 producers delivered milk to the market during the month. Daily deliveries per producer averaged 75,236 pounds, up 0.3 percent from December.

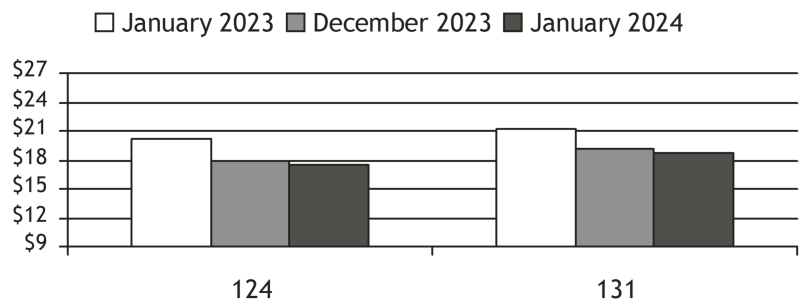
Class I producer milk during January totaled 134.1 million pounds, 22.0 percent of total producer receipts. Daily usage averaged 4.3 million pounds, up 3.7 percent from December. ▼

Arizona (FO 131)

Producers delivered a total of 451.6 million pounds of milk to the market during January. Daily deliveries averaged 14.6 million pounds, up 0.8 percent from December. An estimated 67 producers delivered milk to the market during the month. Daily deliveries per producer averaged 217,447 pounds, up 0.8 percent from December.

Class I producer milk during January totaled 127.4 million pounds, 28.2 percent of total producer receipts. Daily usage averaged 4.1 million pounds, up 6.6 percent from December. ▼

CURRENT COMMODITY PRICES

The AMS survey of cheddar cheese prices showed an increase in prices received for 40-pound blocks and an increase for 500-pound barrels. The survey of 40-pound blocks showed an increase of 11.65 cents between the January 13 and the February 17 surveys, to \$1.6263 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed an increase of 10.73 cents to \$1.5880 per pound.

The AMS butter price showed a net increase of 11.38 cents between the weeks ending January 13 and February 17 from \$2.6447 per pound to \$2.7585 per pound. The AMS nonfat dry milk showed a net increase of 1.65 cents since mid-January to \$1.2237 per pound. The average price for AMS whey showed a net increase of 4.35 cents since mid-January to \$0.4739 per pound. ▼
