MARKET SUMMARIES FOR OCTOBER

Pacific Northwest (FO 124)

Producers delivered a total of 544.8 million pounds of milk to the market during October. Daily deliveries averaged 17.6 million pounds, down 10.3 percent from September. An estimated 254 producers delivered milk to the market during the month. Daily deliveries per producer averaged 69,193 pounds, up 11.2 percent from September.

Class I producer milk during October totaled 135.8 million pounds, 24.9 percent of total producer receipts. Daily usage averaged 4.4 million pounds, up 1.8 percent from September. 📉

Arizona (FO 131)

Producers delivered a total of 305.8 million pounds of milk to the market during October. Daily deliveries averaged 9.9 million pounds, down 3.6 percent from September. An estimated 64 producers delivered milk to the market during the month. Daily deliveries per producer averaged 154,109 pounds, down 3.6 percent from September.

Class I producer milk during October totaled 134.0 million pounds, 43.8 percent of total producer receipts. Daily usage averaged 4.3 million pounds, up 29.1 percent from September. 📈

CURRENT COMMODITY PRICES

The AMS survey of cheddar cheese prices showed a decrease in prices received for 40-pound blocks and a decrease for 500-pound barrels. The survey of 40-pound blocks showed a decrease of 22.87 cents between the October 19 and the November 16 surveys, to \$1.8982 per pound. The survey of 500-pound barrels (adjusted to 38% moisture) showed a decrease of 25.17 cents to \$1.9082 per pound.

The AMS butter price showed a net increase of 7.15 cents between the weeks ending October 19 and November 16 from \$2.6445 per pound to \$2.7160 per pound. The AMS nonfat dry milk showed an increase of 3.54 cents since mid-October to \$1.3838 per pound. The average price for AMS whey showed a net increase of 3.75 cents since mid-October to \$0.5980 per pound. 🐄
