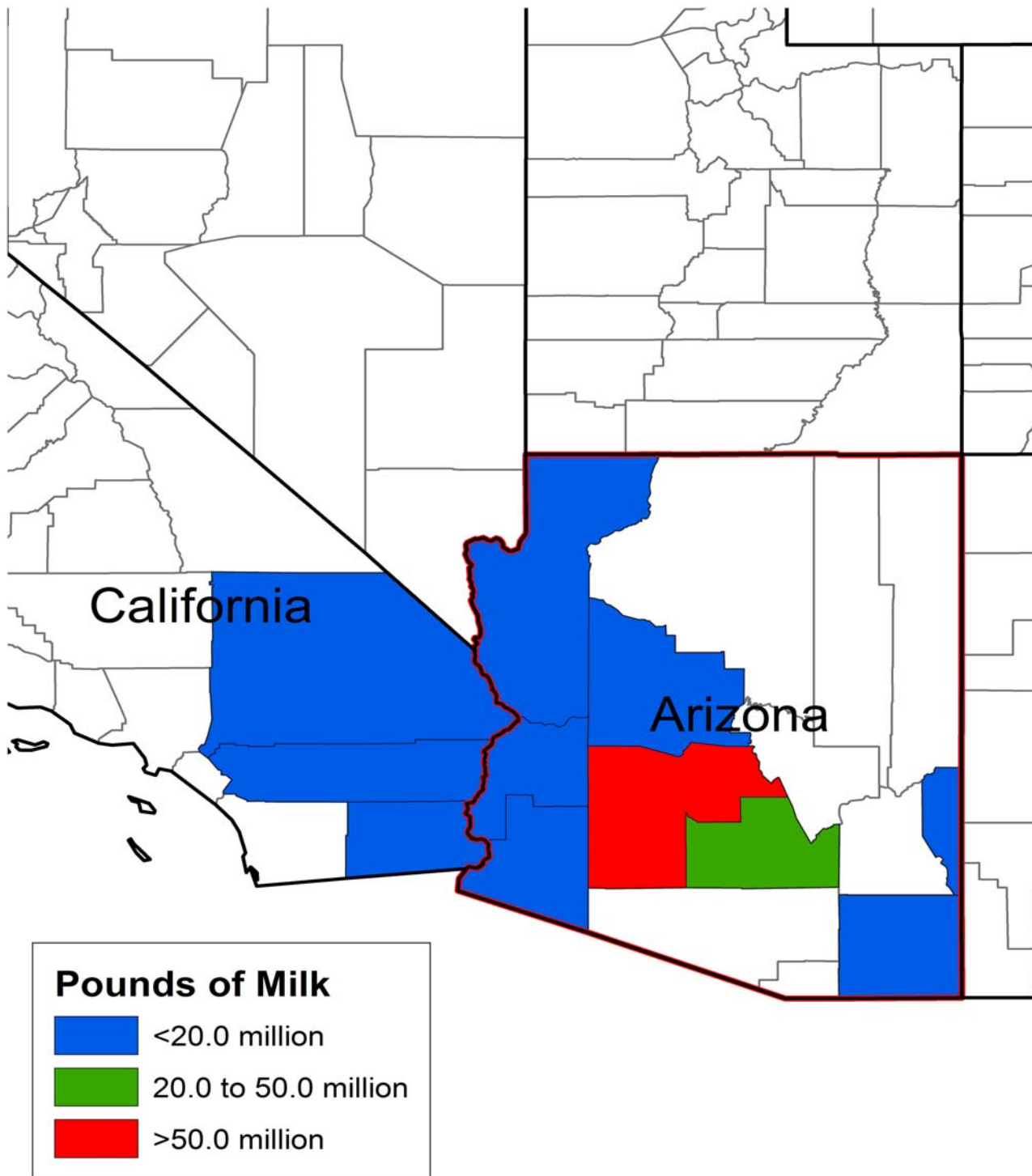

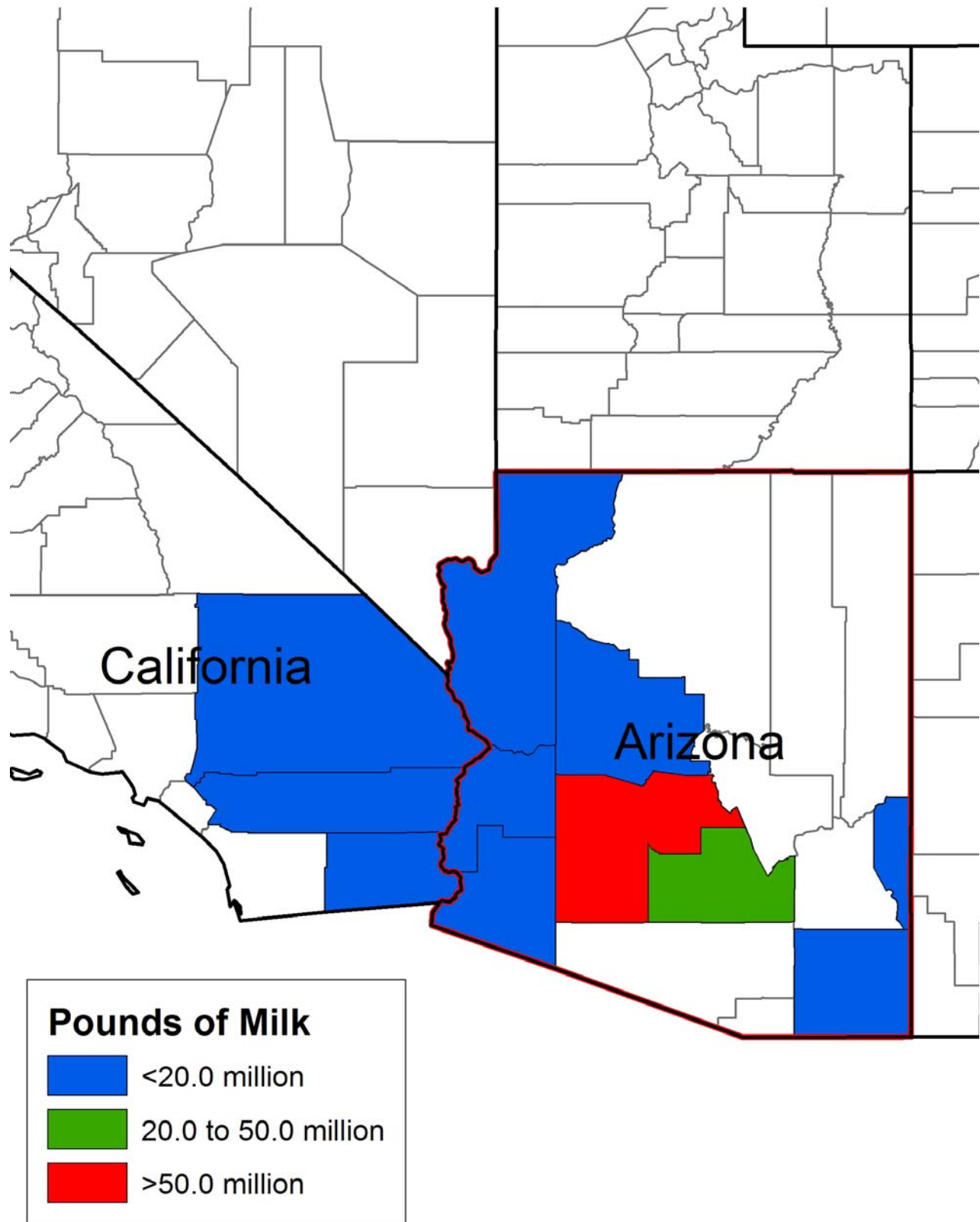

**Arizona Order, Federal Order No. 131 – November 2010**



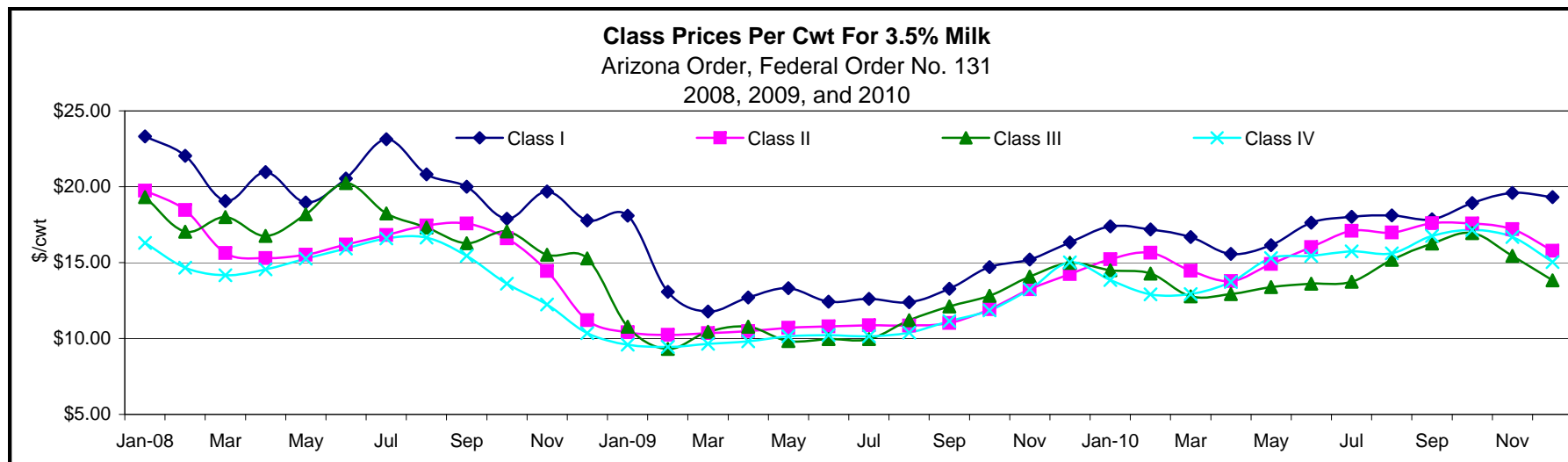
